# INAFSM 2018 Major Accomplishments

Conducted HB 1096 Listening Session: On July 17th, from 10 a.m. to noon, INAFSM hosted a listening session on House Bill 1096. HB 1096, if passed during the 2018 regular session, would have limited MS4's ability to have more stringent requirements than IDEM's Rule 5 in their local ordinances. This was a meaningful discussion with the Senate sponsor of the bill. Professionals with all viewpoints on this issue were encouraged to attend and many participated at the meeting. Some INAFSM Members served as panelists at this session moderated by Tim Haley with Barnes & Thornburg.

As a result of research done by Rodney, it was discovered in 2017 FEMA only awarded roughly \$740,000 in PDM flood acquisition grants nationwide.
